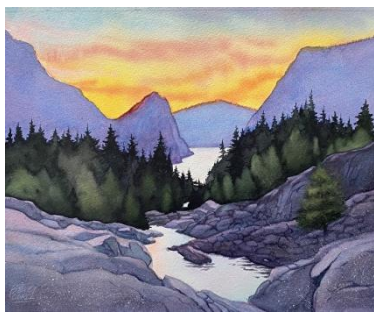

MARCH 26th STEVE CURL (watercolor landscape): Steve is a popular peninsula art instructor both for the Pacific Art League of Palo Alto and for the Redwood City Parks & Recreation Department (both now being done via Zoom). In addition he conducts outdoor workshops. He says he was fortunate to have chosen to pursue the artist’s life as it allows him to spend his time as he wished and actually earn a living from making art and teaching. He paints from his experiences on hikes and excursions where he has spent awestruck moments in each landscape. Watercolor is simple,

spontaneous and surprising, yet challenging to control. It is a joyful, portable medium with supplies easily stowed in a backpack. Setup and cleanup are relatively easy and paintings dry within 10 minutes of completion. All of his paintings seek to capture his experience where a turn in the trail has caught his eye and he is again witness to the rush of beauty and expression of light displayed before him.
