APRIL 22 at 7:00pm (4th not 5th Friday) ZOOM – JOE DEKCER (photography, advanced composition): Joe Decker is a nature photographer, author and educator living in Northern California. Self-taught early in his photographic career, Joe began studying with other masters of nature photography in the late 1990s, including Galen Rowell, Richard Knepp and Bill Atkinson. In 1999 Joe published his award-winning body of work *October*, entirely taken from images created during that month in the Eastern Sierra. In 2003, one of Joe's landscape photographs,

Granite and Snow, Little Lakes Valley, was "highly honored" by the Nature's Best Foundation at the National Museum of History, part of the Smithsonian. In 2008, the National Park Service named him an artist-in-residence at Petrified Forest National Park in Arizona. In 2010, Hurtigrunten awarded him an artist residency in the Disko Bay area of West Greenland, and in 2011 followed up with an additional residency in Svalbard. In 2012 Flatbooks acquired the rights to publish Joe's book "The Tuesday Composition."

The city of Redwood City allows SAG free storage for the panels, so we strive to keep a healthy relationship with the city. Therefore, the panels must be coordinated with our Panel Chairman, Dave McClure, for pickup and delivery. SAG events such as the annual Art Show take precedence over the use of the panels. Number of panels on loan at that time may be reduced.
